

Official Rules (“Official Rules”)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY.

This Sweepstakes is open only to individuals who are legal residents of the California, who are at least **18 years of age or older**, and who reside within one of the following Southern California Counties: Santa Barbara, Ventura, Los Angeles, San Bernardino, Orange, Riverside, San Diego or Imperial (collectively, the “Eligible Counties”) at the time of entry. If you are not a legal resident of California, you do not reside in one of the Eligible Counties or you are not the required age as of time of entry, you are not eligible to participate in this Sweepstakes or to win a prize. Company and Sweepstakes Entities (both as defined below), individuals from all other radio and television stations, and members of the immediate family of any such persons are not eligible to participate or win. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

The Sweepstakes is administered by Company and any questions, comments or complaints regarding the Sweepstakes must be directed to Company.

1. DESCRIPTION OF SWEEPSTAKES/PARTICIPATION.

This Sweepstakes consists of two (2) first round drawings as described below ("First Round Finalist Drawings") and one (1) drawing held at KIIS-FM's Jingle Ball Village at The Forum Parking Lot on December 6, 2019 as described below ("Grand Prize Event").

Dates of Sweepstakes: Sweepstakes begins on **November 4, 2019 at 12:00:00 AM** Pacific Daylight Time ("PDT") and ends on **December 6, 2019 at 4:15:00 PM Pacific Standard Time** ("PST") ("Sweepstakes Period"). All entries must be received no later than end time/date of the entry period for the applicable Entry Method to be valid.

How to Enter the First Round Finalist Drawing: Five (5) total entrants will be randomly selected as Finalists to participate in the Grand Prize Event, subject to verification (each a "Finalist"). There are two (2) ways to enter the First Round Finalist Drawings for the opportunity to become a Finalist (each an "Entry Method"):

2) Onsite Registration Entry Method (the "Onsite Registration"): To enter the Sweepstakes via the Onsite Registration Entry Method, during the Onsite Registration Entry Period, visit the Sweepstakes' brand ambassador at the Chevy activation space held at KIIS-FM's Jingle Ball Village located at The Forum Parking Lot, 3900 W Manchester Blvd, Inglewood, CA 90305 (admission to the Jingle Ball Village is free and open to the public), between 2:00:00 PM PST and 4:15:00 PM PST on December 6, 2019, and complete and submit the official Sweepstakes entry form with all information requested by Sponsor to receive one (1) entry into the Onsite Registration Drawing. **Limit: One (1) entry per person/email address during the Onsite Registration Entry Period.** Valid entries must contain all information requested. Multiple entrants are not permitted to share the same email address and/or telephone number. Should multiple users of the same e-mail account or telephone number, as applicable, enter the Sweepstakes and a dispute thereafter arise regarding the identity of the entrant, the authorized account holder of said e-mail account or telephone number at the time of entry will be considered the entrant. "Authorized account holder" is defined as the natural person who is assigned an e-mail address or telephone number by an Internet access provider, on-line service provider, telephone service provider or other organization which is responsible for assigning e-mail addresses, phone numbers or the domain associated with the submitted e-mail address. Proof of a submission of an entry shall not be deemed proof of receipt by Company. Company's computer will be deemed the official time keeping device for the Sweepstakes. Each Finalist must be available to attend, participate in, and be eligible for the Grand Prize Event scheduled to be held on December 6, 2019 from 4:45 PM PST to 5:15 PM PST at the KIIS-FM's Jingle Ball Village (located at The Forum Parking Lot, 3900 W Manchester Blvd, Inglewood, CA 90305) and check in with Station representatives at the Grand Prize Event before 4:15 PM PST. Each Finalist must also be available to attend and participate in KIIS-FM's Jingle Ball event on the evening of December 6, 2019.

Onsite Registration Finalists will be notified via the phone number provided during registration on December 6, 2019 around 4:16 PM PST. **Once notified, Onsite Registration Finalists will have ten (10) minutes to report back to the Chevy activation space.** In the event that the Station is unable to contact the Onsite Registration Finalist, or the Onsite Registration Finalist does not check in at the on-site Chevy activation space within the time specified, such Finalist may be disqualified (in Company's sole discretion) and the Station reserves the right to select another Finalist at its sole discretion.

Notification is deemed to have occurred immediately upon placing of a phone call or sending of an e-mail or any other form of communication Company may use to contact the Finalists and/or a potential winner. GRAND PRIZE EVENT: Only verified and qualified Finalists may participate in the Grand Prize Event. Company, Sponsor, and Released Parties (as defined below) are not in any way responsible or liable for damages resulting from shipping and handling, loss, and/or use or misuse of any prize awarded in this Sweepstakes. **The prizes will only be awarded if properly claimed according to these Official Rules. Four (4) Finalist First Place Prizes: Four (4) verified First Place winners will each receive two (2) tickets to the KIIS-FM's Jingle Ball event held on December 6, 2019 at The Forum, 3900 W Manchester Blvd, Inglewood, CA 90305. **ARV of each First Place prize: \$200 USD. NO TRAVEL ACCOMMODATIONS, FOOD, DRINKS, PARKING, BACKSTAGE ACCESS, OR OTHER COMPONENTS SHALL BE PROVIDED FOR THE CONCERT.**

Total ARV of all prizes: \$1,200 USD.

KIIS-FM's Jingle Ball Conditions: Winners are solely responsible for travel to and from KIIS-FM's Jingle Ball and any and all other associated costs and expenses. **Each Winner must be available on December 6, 2019.** If any Winner is not available for the concert on December 6, 2019, at the specified time, such Winner will be disqualified (in Company's sole discretion). Company reserves the right to not award the prize(s) associated with KIIS-FM's Jingle Ball in the event that event is canceled without any payment or obligation to the Winner(s). Prize(s) are subject to certain terms and conditions specified thereon. Location of seats and ticket type are in Company's sole discretion. Each Winner and his/her guest agree to comply with all applicable venue regulations in connection with the KIIS-FM's Jingle Ball event. Company and the applicable venue representatives reserve the right to remove or to deny entry to any Winner (and his/her guest) who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the concert or in any other objectionable behavior.
